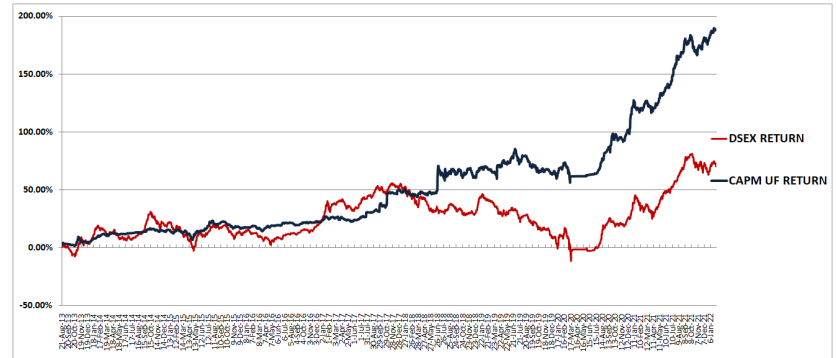
### Investment Objective

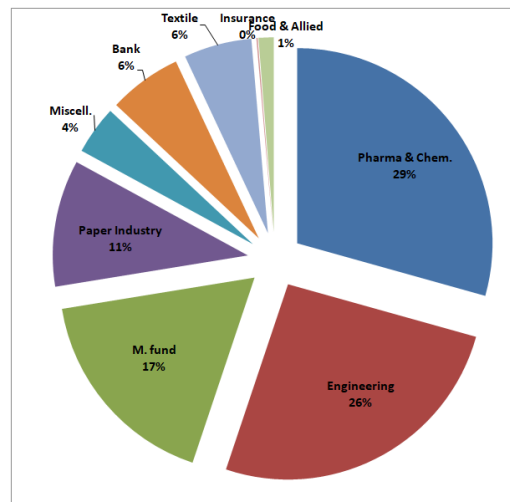
